RECOMMENDED ACTION AND JUSTIFICATION:

It is respectfully recommended that your Board enter into a contract (Contract #03-73033-000) with the California State Department of Mental Health to provide specialty mental health services to Medi-Cal beneficiaries of Mariposa County through the Human Services Department during fiscal year 2003-04. \$133,869.00 has been allocated to Mariposa County by the State of California for this purpose.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Mariposa County contracts with the State Department of Mental Health on an annual basis to establish community mental health services for the county through the Human Services Department.

The Department of Mental Health requires that this contract be approved so that Mariposa County can continue to receive Medi-Cal funds for specialty mental health services during the current fiscal year.

Recommendation

It is respectfully recommended that your Board authorize the Human Services Department to continue to contract with the State Department of Mental Health to provide specialty mental health services to Mariposa County Medi-Cal beneficiaries.

Background/Current Situation

To continue to receive State funds for specialty mental health services, Mariposa County contracts with the State Department of Mental Health on an annual basis. On August 18, 2003 the State forwarded the contract for the current fiscal year. The County needs to enter into this contract to receive necessary Medi-Cal Managed Care funds.

Financial

Revenue in the amount of \$133,869.00 has been allocated to Mariposa County to provide specialty mental health services for Medi-Cal beneficiaries. Approval of this contract will allow the State Department of Mental Health to release these funds.
