**MARIPOSA COUNTY RESOLUTION 03-351  
PROCLAIMING OCTOBER 22<sup>nd</sup> THROUGH 31<sup>st</sup>, 2003  
AS "RED RIBBON WEEK"**

WHEREAS, alcohol and other drug abuse is a danger to everyone in our community, causing untold human misery through injuries, deaths, broken homes and wasted lives, enslaving the user and putting the innocent at risk; and

WHEREAS, young people, parents, seniors, government, schools, religious and service organizations, businesses, law enforcement agencies, health professionals and institutions, the media and general public wish to demonstrate their opposition to the evils of substance abuse by wearing and displaying red ribbons during a week-long celebration; and

WHEREAS, Californians for Drug-Free Youth, Inc. and the National Family Partnership wishes to offer all citizens the opportunity to "Take a Minute; Make a Difference" in the life of their communities by sponsoring an annual RED RIBBON CELEBRATION as well as year-round prevention of alcohol and other drug abuse; and

WHEREAS, the County of Mariposa further commits resources to ensure the success of the RED RIBBON CELEBRATION and all activities that promote healthy, drug-free lifestyles throughout the year;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of Mariposa County, a political subdivision of the State of California, does hereby designate October 22<sup>nd</sup> through October 31<sup>st</sup>, 2003 as "RED RIBBON WEEK," and encourages all citizens to participate in alcohol and other drug prevention programs and activities, making a visible commitment to developing healthy, drug-free communities in which to raise a generation of drug-free youth.
