Authorize Chairman to adopt resolution and accept funding for the fiscal year 2003-2004 in the amount of \$182,233 for the continuation of the Mariposa County Drug Task Force Grant administered by the Office of Criminal Justice Planning. The monies are federal funds passed through the State. The Drug Task Force Grant is an ongoing grant and this is a reapplication for funds to be used for personnel and benefits within the Sheriff's Department, Probation Department and the District Attorney's Office. In accordance with grant requirements, funding is also utilized for mandatory Office of Criminal Justice training conferences, and for equipment.

Mariposa County has participated in the O.C.J.P. Drug Enforcement Grant Program for approximately thirteen years.
