WHEREAS, DIANNE is recognized in the community as a high spirited and successful business leader; and


WHEREAS, DIANNE has supported several church and civic fundraisers, sponsored many youth sports programs and generously donates to area schools; and,



**WHEREAS, GREG** is recognized in the community as a dedicated, successful business leader; and






