MARIPOSA COUNTY ORDINANCE NO. 1072

AN ORDINANCE CREATING A NEW CHAPTER 15.30 OF THE MARIPOSA COUNTY CODE ENTITLED "ADOPTION OF FIRE CODE"

WHEREAS, the Board of Supervisors desire to create a new Chapter 15.30 of the Mariposa County Code; and

WHEREAS, the adoption of the 2010 edition of the California Fire Code will protect the health, safety and welfare of the citizens of Mariposa County by regulating and governing the conditions and maintenance of all buildings and structures;

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I: Chapter 15.30 of the Mariposa County Code is hereby created and shall read as follows:

15.30.010 Adoption of Fire Code.

Pursuant to Section 50022.2 of the California Government Code, the following codes are adopted by reference and are applicable to and shall govern all buildings and structures within the county, except those which are exempted by state or federal law:

A. The California Fire Code, 2010 Edition, Chapters 1-48, including Appendix B, BB, C, CC, D, and I.

SECTION II: This Ordinance shall become effective thirty (30) days after final passage pursuant to Government Code §25123.
