**MARIPOSA COUNTY ORDINANCE NO. 1048**

**AN ORDINANCE CREATING CHAPTER 2.30 OF THE MARIPOSA COUNTY CODE ENTITLED "DEPARTMENT OF TECHNICAL SERVICES"**

**WHEREAS**, the Board of Supervisors of the County of Mariposa desire to create Chapter 2.30 to the Mariposa County Code; and

**WHEREAS**, creating Chapter 2.30 will provide a description for the operation of the Department of Technical Services;

**NOW, THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY**, a political subdivision of the State of California, does ordain as follows:

**SECTION I:**

**Department of Technical Services**

Sections:

- 2.30.010 Created.
- 2.30.020 Responsibilities.
- 2.30.030 Employees.

2.30.010 Created.

There is hereby created in the County of Mariposa the Department of Technical Services. This department shall be directed by a Technical Services Director who shall be appointed by the Board of Supervisors, shall be a department head, and shall serve at the pleasure of the Board of Supervisors.

2.30.020 Responsibilities.

The Technical Services Department shall be responsible to maintain County computer and communications equipment, maintain the availability of the computer network, and safeguard networked County data from loss due to disaster or malicious attack.

2.30.030 Employees.

The department of Technical Services shall be staffed as determined by the Board of Supervisors from time to time.

**SECTION II:** This Ordinance shall become effective thirty (30) days after final passage pursuant to Government Code Section 25123.
