MARIPOSA COUNTY ORDINANCE NO. 1009

**AN ORDINANCE AMENDING SECTION 9.20.030 OF
CHAPTER 9.20 OF THE MARIPOSA COUNTY CODE**

WHEREAS, the Board of Supervisors of the County of Mariposa desire to amend Section 9.20.030 of Chapter 9.20 to the Mariposa County Code; and

WHEREAS, amending Section 9.20.030 will prohibit smoking in all county vehicles;

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I:

9.20.030 Definitions.

C. "County workplace" means any enclosed building area where county employees work which is owned, leased, operated or used by Mariposa County, including areas where public meetings and/or committee meetings are conducted. Included in this definition are county vehicles.

SECTION II: This Ordinance shall become effective thirty (30) days after final passage pursuant to Government Code Section 25123.


