MARIPOSA COUNTY ORDINANCE NO. 958

AN ORDINANCE AMENDING SECTIONS 2.36.010 AND 2.36.040 OF CHAPTER 2.36 OF THE MARIPOSA COUNTY CODE

WHEREAS, the Board of Supervisors desire to amend Sections 2.36.010 and 2.36.040 of Chapter 2.36 of the Mariposa County Code, and

WHEREAS, the County of Mariposa has recently created a County Surveyor position in the Public Works Department alleviating the need for the Director of Public Works to serve as the "County Engineer/Surveyor," and

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I: Sections 2.36.010 and 2.36.040 of Chapter 2.36 of the Mariposa County Code are hereby amended to read as follows:

2.36.010 Created.

There is hereby created in the County of Mariposa the Department of Public Works. This department shall be directed by a Director of Public Works who shall be appointed by the Board of Supervisors, shall be a department head, and shall serve at the pleasure of the Board of Supervisors. The department head shall serve as the "County Engineer," the "Road Commissioner," and may serve as the "County Surveyor."

2.36.040 Employees.

E. The Engineer/Surveyor Division shall consist of the Director of Public Works, Engineer, a County Surveyor, and such other employees as may be provided by the Board of Supervisors.

SECTION II: This Ordinance shall become effective thirty (30) days after final passage pursuant to Government Code § 25123.
