

MARIPOSA COUNTY ORDINANCE No. 725

REPEALS ORDINANCE 681  
WHICH ADDED SECTIONS 2.56.100 THROUGH 2.56.150  
ESTABLISHING THE PARKS AND RECREATION DEPARTMENT, AND  
FUNCTIONS OF THE DIRECTOR OF PARKS AND RECREATION, AND  
RESCINDS AND REPLACES SUBSECTION "B" OF 2.56.050, AND  
SUBSECTION "C" OF 2.56.090 OF CHAPTER 2.56 ENTITLED  
"BOARD OF RECREATION COMMISSIONERS"

THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I: The Board of Supervisors of Mariposa County hereby repeals Ordinance No. 681 which established the Parks and Recreation Department, and outlined the functions of the Director of Parks and Recreation. Those Sections repealed are more specifically identified as Sections 2.56.100 through 2.56.150 in their entirety.

SECTION II: Rescinds and replaces Subsection "B" of Section 2.56.050 entitled "Organization" of Chapter 2.56 entitled "Board of Recreation Commissioners" to read in its entirety as follows:

"B. The deputy director-public works, parks and recreation division, may be appointed secretary to the board of recreation commissioners by the board of recreation commissioners."

SECTION III: Rescinds and replaces Subsection "C" of Section 2.56.090 entitled "Powers and Duties" of Chapter 2.56 entitled "Board of Recreation Commissioners" to read in its entirety as follows:

"C. Act in an advisory capacity to the board of supervisors and to the deputy director-public works, parks and recreation division, in the planning, maintenance, development and operation of all recreation areas and facilities owned, controlled, or leased by the county;"


SECTION IV: This ordinance shall become effective thirty (30) days from the date of final passage pursuant to California Government Code Section 25123.




