

1 MARIPOSA COUNTY ORDINANCE NO. 624

2 AN ORDINANCE AMENDING THE ZONING MAPS FOR THE TIMBER
3 PRODUCTION ZONE AND UNCLASSIFIED ZONES (not to be
4 codified in Code text)

5 WHEREAS, an application for change of zone was heard by the Planning Com-
6 mission on the property referred to as Assessor's Parcel Number 005-070-008-0 and
7 a recommendation by Planning Commission Resolution No. 84-29 was made that the
8 application be granted; and

9 WHEREAS, a public hearing was held by the Board of Supervisors on July 24,
10 1984 after due Notice as required by law, and the application approved.

11 NOW THEREFORE THE Board of Supervisors of Mariposa County, a political sub-
12 division of the State of California does hereby ordain as follows:

13 SECTION I

14 Pursuant to Section 17.06.010 of the Mariposa County Code, the official
15 zoning maps of the County of Mariposa shall be amended to remove the following
16 described property from the Timber Preserve Zone as established by Ordinance No.
17 464 and subsequent amendments thereto, and add said property to the Unclassified
18 Zone as established by Ordinance No. 345 and subsequent amendments thereto. Said
19 maps are to be amended on the 10th anniversary of the effective date of this
20 Ordinance.

21 LEGAL DESCRIPTION: Parcel "C" Map for Timothy Manly, recorded May 8, 1974
22 in Book 7 of Parcel Maps, page 47, Mariposa County Records.

23 SECTION II

24 In the event that the County of Mariposa adopts a Zoning Ordinance for the
25 purposes of implementing the Mariposa County General Plan; the subject property
26 shall be re-zoned in accordance with the General Plan Land Use Classification
27 applied to the property at the time of the Tenth Anniversary of the effective
28 date of this Ordinance.

SECTION III


This Ordinance shall take effect 30 days after the date of passage, pursuant to Government Code Section 25123.


