ORDINANCE NO. 184

The Board of Supervisors of the County of Mariposa do ordain as follows:

SECTION 1. County Ordinance Number 174 is hereby amended as follows:

A. The following class is hereby added to the Monthly Salary schedule designated in Section 8 thereof, to wit:

"Class	A	B	C	D	E

B. Section 9 thereof is hereby repealed, and the following Section 9 is hereby enacted in lieu thereof, to wit:

"SECTION 9. Departmental Classification Allocations. The various county offices and departments are hereby allocated employees according to number and classification as follows:

12 "SECTION 10. The salaries of the following County and
13 District Officers and employees are hereby fixed as follows:

- 14 (a) The County Assessor shall receive a salary of
15 \$4,800.00 per annum until December 31, 1958, and
16 shall receive a salary of \$6,000.00 per annum
17 commencing January 1, 1959.
- 18 (b) The County Clerk shall receive a salary of \$4,200.00
19 per annum until December 31, 1958, and shall receive
20 a salary of \$5,600.00 per annum commencing January 1,
21 1959.
- 22 (c) The County Recorder shall receive a salary of
23 \$2,600.00 per annum until December 31, 1958, and
24 shall receive a salary of \$3,000.00 per annum com-
25 mencing January 1, 1959.
- 26 (d) The County Sheriff shall receive a salary of
27 \$5,000.00 per annum until December 31, 1958, and
28 shall receive a salary of \$6,000.00 per annum com-
29 mencing January 1, 1959.
- 30 (e) The County Treasurer and Tax Collector shall receive
31 for the combined office a salary of \$4,400.00 per
32 annum until December 31, 1958, and shall receive

for the combined office a salary of \$5,600.00 per annum commencing January 1, 1959.

(f) The Judge of the Mariposa Judicial District Court shall receive a salary of \$4,200.00 per annum.

(g) The Judge of the Coulterville Judicial District Court shall receive a salary of \$1,500.00 per annum.

(h) The Constable of Mariposa Judicial District shall receive a salary of \$2,460.00 per annum.

(i) The Constable of Coulterville Judicial District shall receive a salary of \$1,500.00 per annum.

(j) The Road Commissioner shall receive a salary of \$7,200.00 per annum.

(k) The Public Health Officer shall receive a salary of \$600.00 per annum.

(l) The Probation Officer shall receive a salary of \$960.00 per annum.

(m) The County Surveyor shall receive \$4.00 per hour for time actually worked."

SECTION 2. Except as hereinabove otherwise provided, the salaries and salary scales herein provided shall become effective as of October 1, 1957.
