Approve the resolution authorizing a transfer within the Fire Department for \$1,000 for blood tests. Blood tests are required and paid for by the County on all new volunteer firefighter applicants. The original budgeted amount of \$1,000 has been depleted.

Requesting the transfer from the mechanic salary, as there is a savings from not hiring at mid step and due to date of hire.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Fasting Cholestrerol/Glucose blood test is a requirement by the County. The Board has previously approved transfers similar to this request, although no action has been taken this fiscal year.
