

1 MARIPOSA COUNTY RESOLUTION NO. 90-116

2 A RESOLUTION OF INTENTION TO INITIATE THE DESIGNATION PROCESS
3 FOR OFFICIAL STATE DESIGNATION OF HIGHWAY 140 AS A SCENIC
4 HIGHWAY FROM THE NORTHERN MARIPOSA TPA BOUNDARY TO THE ENTRANCE
5 OF YOSEMITE NATIONAL PARK

6 WHEREAS, the California State Legislature established the
7 California Scenic Highway Program through Senate Bill 1467; and

8 WHEREAS, Highway 140 from the northern Mariposa TPA
9 boundary to the entrance of Yosemite National Park (hereafter
10 referred to as the Scenic Route) is included in The Master Plan
11 of State Highways Eligible for Official Scenic Highway
12 Designation; and

13 WHEREAS, official designation of the Scenic Route as a
14 Scenic Highway is consistent with the Scenic Highways Element of
15 the Mariposa County General Plan; and

16 WHEREAS, the local effects of official designation have
17 been identified as the protection of the recreational, social
18 and economic values derived from the protection and enhancement
19 of the scenic qualities of the County, for the benefit of
20 residents and visitors; the promotion of the overall economic
21 vitality of the district; the enhancement of tourism; and the
22 stabilization and increase of property values in the district;

24 WHEREAS, the County must provide the Caltrans District
25 Director of Transportation with a Resolution of Intention to
26 initiate the designation process.



NOW THEREFORE BE IT RESOLVED that the Mariposa County Board of Supervisors does hereby adopt this Resolution of Intention to establish an Official Scenic Highway along the route shown in the attached exhibit, and that the Mariposa County Planning Department is hereby directed to submit this Resolution of Intention to the Caltrans District Director of Transportation with the required accompaniments, and that the Mariposa County Planning Department is hereby directed to initiate proceedings to prepare and adopt a program to protect and enhance the Scenic Route in accordance with State Law upon receipt of the Caltrans Departmental Transportation Advisory Committee's approval to proceed.


