RECOMMENDED ACTION AND JUSTIFICATION:

Approve resolution authorizing appropriation of \$6,676 for ambulance housing and utilities at Mariposa and Coulterville.

This period would be July 1, 1989 - June 30, 1990. It is recommended that these funds be put in the Fire Protection Budget in the contract line item with CDF.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

In 1989, it was agreed to house the ambulance at CDF facilities for \$200/month and \$50/month for utilities. One ambulance is housed at Coulterville CDF and the other is at Mariposa CDF. During budget hearings of 1989/90, it was agreed to do the same and at the same price.
