MARIPOSA COUNTY RESOLUTION NO. 90-153

A RESOLUTION VACATING AND ABANDONING A PORTION OF
COUNTY ROAD CORNETT'S ENTRANCE ROAD

WHEREAS, the Mariposa County Board of Supervisors has passed and adopted Resolution No. 90-101, which stated its intention to abandon a portion of County Road CORNETT'S ENTRANCE ROAD; and

WHEREAS, the Board of Supervisors set a public hearing on this matter, and public notice of said hearing has been properly posted and published; and

WHEREAS, the necessary public hearing has been held pursuant to law; and

WHEREAS, the Board of Supervisors affirmatively finds that that portion of

Mariposa County Road No. 68A, Cornett's Entrance Road, situated in Sections 22, 23, 26 and 27, T.6S., R.16E., M.D.B.&M., County of Mariposa, State of California; Beginning at a point 1.0 mile from the intersection of County Road No. 9A, Old Highway, to the end a distance of 0.5 miles

is unnecessary for present or prospective public use within the meaning of Streets & Highways Code Section 8320.

NOW, THEREFORE, IT IS RESOLVED that this Board hereby determines and orders as follows:


1. The County of Mariposa, by and through its Board of Supervisors, abandons that portion of County Road CORNETT'S ENTRANCE ROAD as described in this resolution pursuant to Streets & Highways Code Section 8320.

2. That a certified copy of this resolution be recorded in the office of the Mariposa County Recorder by the Clerk of the Board, and upon such recordation, the abandonment shall be complete. That said recordation shall not be made until a turnaround has been constructed by the adjacent owners and the Mariposa County Department of Public Works has approved said turnaround.
