RECOMMENDED ACTION AND JUSTIFICATION:

Public Works recommends that the Board of Supervisors (BOS) reject all bids received for Request for Quotation (RFQ) No. PW-90-09 and purchase the vehicle through the City of Barstow. This RFQ was advertised to purchase a Transit Bus, but as shown on the attached Bid Summary only one bid was received for \$48,205.63. The estimated cost of the bus was anticipated to be between \$40,000 and \$45,000.

Public Works recommends that the BOS approve the purchase of the transit bus by "tagging on to" a purchase order from the City of Barstow. The cost to the County would be \$39,851.00; \$8,354.63 less than Razzari Ford price. Tagging on to another government agency's purchase order allows Mariposa County to benefit from the volume discounts that larger agencies enjoy.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The BOS approved the advertisement of this RFQ on May 22.
