
CONFIRMING EXISTENCE OF A LOCAL EMERGENCY

CONFIRMING EXISTENCE OF A LOCAL EMERGENCY

WHEREAS, ON AUGUST 8, 1990 THE DIRECTOR OF EMERGENCY SERVICES OF THE COUNTY OF MARIPOSA FOUND THAT DUE TO EXTENSIVE FIRES THROUGHOUT THE AREA, A CONDITION OF EXTREME PERIL TO LIFE AND PROPERTY DID EXIST WITHIN SAID COUNTY; AND

WHEREAS, IN ACCORDANCE WITH STATE LAW THE BOARD OF SUPERVISORS OF THE COUNTY OF MARIPOSA IS EXPECTED TO CONFIRM THE DIRECTOR'S ACTION AT A SPECIAL MEETING OF THE BOARD ON AUGUST 10, 1990; AND


WHEREAS, IT HAS BEEN FOUND THAT LOCAL RESOURCES ARE UNABLE TO COPE WITH THE EFFECTS OF SAID EMERGENCY;

NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND ORDERED THAT A COPY OF THIS RESOLUTION BE FORWARDED TO THE GOVERNOR OF CALIFORNIA WITH THE REQUEST THAT HE PROCLAIM THE COUNTY OF MARIPOSA TO BE IN A STATE OF EMERGENCY; AND


IT IS FURTHER ORDERED THAT A COPY OF THIS RESOLUTION BE FORWARDED TO THE STATE DIRECTOR OF EMERGENCY SERVICES; AND

IT IS FURTHER RESOLVED THAT MR. ARTHUR B. BAGGETT, JR., THE CHAIRMAN OF THE BOARD OF SUPERVISORS, IS HEREBY DESIGNATED AS THE AUTHORIZED REPRESENTATIVE FOR PUBLIC ASSISTANCE AND MR. ARTHUR R. BAGGETT, JR., THE CHAIRMAN OF THE BOARD OF SUPERVISORS, IS HEREBY DESIGNATED AS THE AUTHORIZED REPRESENTATIVE FOR INDIVIDUAL ASSISTANCE FOR THE COUNTY OF MARIPOSA FOR THE PURPOSE OF RECEIPT, PROCESSING, AND COORDINATION OF ALL INQUIRIES AND REQUIREMENTS NECESSARY TO OBTAIN AVAILABLE STATE AND FEDERAL ASSISTANCE.

PROCLAMATION

PROCLAIMING EXISTENCE OF A LOCAL EMERGENCY  
(By Mariposa County's Director of Emergency Services)

WHEREAS, Ordinance No. 600 of the County of Mariposa empowers the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when said County is affected or likely to be affected by a public calamity and the Board of Supervisors is not in session; and

WHEREAS, the Director of Emergency Services of the County of Mariposa does hereby find:

That conditions of extreme peril to the safety of persons and property have arisen within said County, caused by two wild land fires which are at present out of control and are threatening the property and lives in the Mariposa communities of El Portal, Foresta and Yosemite West. Additionally, the lives and property of those individuals utilizing the National Forest and Bureau of Land Management portions of the Merced River Canyon are endangered;

That the Board of Supervisors of the County of Mariposa is not in session and cannot immediately be called into session;

NOW THEREFORE, IT IS HEREBY PROCLAIMED by the Director of Emergency Services of Mariposa County that a local emergency now exists throughout said County, and the Director of Emergency Services of Mariposa County hereby requests the Governor of the State of California to declare a State of Emergency in Mariposa County as a result of the fire conditions described above; and

PROCLAIMING EXISTENCE OF A LOCAL EMERGENCY  
(By Mariposa County's Director of Emergency Services)

WHEREAS, Ordinance No. 600 of the County of Mariposa empowers the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when said County is affected or likely to be affected by a public calamity and the Board of Supervisors is not in session; and
