RECOMMENDED ACTION AND JUSTIFICATION:

Approve appropriation of \$1,089 to the Fire Department training line item. These funds were received from Merced College for the first responder class taught by CDF personnel. When the course is offered through the College, they will pay the instructors. The funds are used to purchase training items and to provide out of county training. Out of county training includes hiring instructors for specialized training or to send volunteers to one/two day training classes.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Board has always approved the appropriation of these funds. Agreements have been made with the County and College specifying these terms and conditions but the agreement with Merced College expired in July. The 90/91 agreement is in process now and will be presented to the Board for approval in the near future.

The alternative is to not approve appropriation. If the funds are not put back into the training program, the instructors will have no incentive to teach the classes.
