- 3) Approve attached detailed budget plan for County and State funds for Mining and Mineral Exhibit and authorizing Auditor to draw warrants to California Mining and Mineral Exhibit Association for costs incurred to date.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Based upon State budget action, the State has appropriated \$50,000 to the County to manage the curation function and the County has budgeted the required \$18,000 match for the mineral exhibit. These funds will provide housing and related costs for the gems and minerals. This Board action carries out the intent of the State appropriation and the Board's previous action during the budget hearings.
