RECOMMENDED ACTION AND JUSTIFICATION:

Counsel recommends the approval of the attached Amended Description and Map of the Town of Mariposa for the relinquishment of a portion of County-owned property at 4th Street south of Highway 140 and the acceptance of property or rights-of-ways. A Resolution for the summary abandonment of a portion of 4th Street was adopted by the Board of Supervisors at the October 23, 1990 meeting, however, the map description was subsequently revised.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On October 23, 1990, the Board unanimously voted in favor of relinquishing a portion of 4th Street for the purpose of improving the access to the Mariposa Creek Project.

AMENDED DESCRIPTION

All of that portion of Fourth Street as shown on the Map of the Town of Mariposa, recorded as Map Number 313, Mariposa County Records, situated in projected Section 23, Township 5 South, Range 18 East, M.D.B. & M., Rancho Las Mariposas, Mariposa County, California, and being more particularly described as follows:

Beginning at the intersection of the westerly right-of-way line of State Highway 140 with the southerly line of Fourth Street; thence along said southerly line of Fourth Street, south $53^{\circ} 50' 23''$ west, 123.96 feet; thence leaving said southerly line, north $10^{\circ} 33' 06''$ west, 39.92 feet; thence along a line parallel to and 36 feet distant from said southerly line of Fourth Street, north $53^{\circ} 50' 23''$ east, 106.71 feet to the above said westerly right-of-way line of State Highway 140; thence along said westerly right-of-way line, south $36^{\circ} 09' 22''$ east, 36.00 feet to the Point of Beginning.

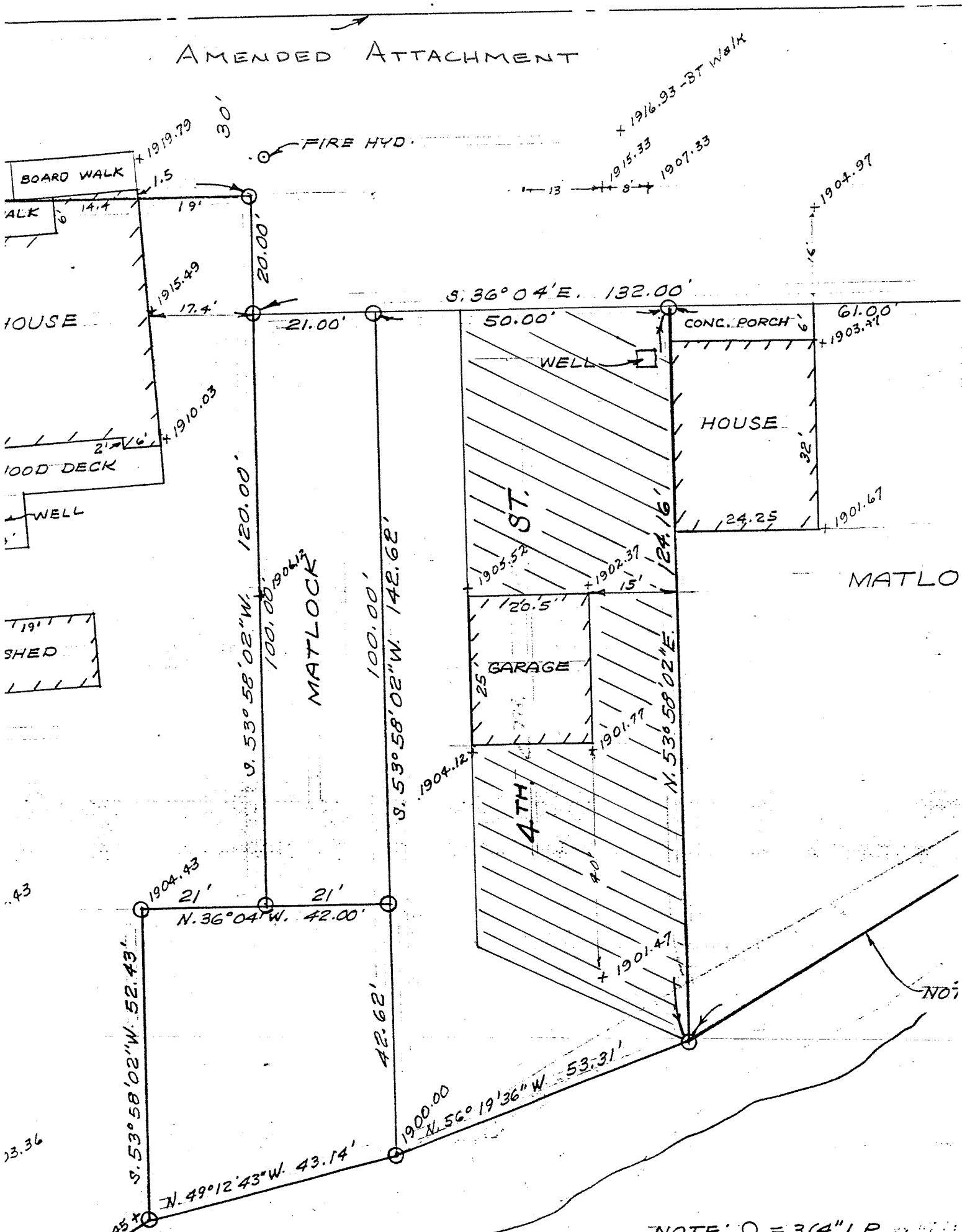
