RECOMMENDED ACTION AND JUSTIFICATION:

Public Works recommends that the Board of Supervisors (BOS) award a bid for a 1991 5 passenger 4x4 for the Sheriff's Department to the lowest bidder meeting specifications, Tom DeBose Chevrolet, in the amount of \$22,193.40

During the budget process, the Board approved a one-time funding of \$37,500 for the purchase of emergency vehicles for the Sheriff's Office. The vehicles are additional to the fleet, but presently replace out of service damaged vehicles. An emergency equipment sedan was purchased through a tag-on process approved by the Board on 11/13/90. The above vehicle bid was advertised and bids were opened December 11, 1990. Three bids were received. The recommended bidder was the lowest bidder that met the required specifications. Copies of the bids are on file in the Public Works Department.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On 11/13/90, the Board was noticed in accordance with Ordinance No. 761 that the Department of Public Works would be advertising for and opening bids on December 4, 1990.

1. Award the bid to a different bidder, the specifications might not be met or the cost might be higher.
2. Do not award the bid. The Sheriff will not have the needed vehicles allocated.
