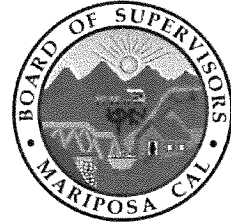

RE: Ordinance Rescinding Chapter 2.30 of the Mariposa County Code

RECOMMENDED ACTION AND JUSTIFICATION:

Waive the Second Reading and Adopt an Ordinance Rescinding Chapter 2.30 of the Mariposa County Code.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

At its meeting of December 4, 2018, the Board of Supervisors approved consolidating the Department of Technical Services into County Administration. As a result, Chapter 2.30 of the Mariposa County Code entitled "Department of Technical Services" needs to be rescinded to be consistent with current practices.

The Ordinance was introduced at the December 11, 2018 meeting.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

County Code will not accurately reflect the County's structure.
