

NOTICE OF CURRENT PROPERTY TAXES DUE

Keith M. Williams, Mariposa County Tax Collector, hereby announces that regular secured tax bills will be mailed on or before November 1, 2021, to all property owners, at the addresses shown on the tax roll. If you own property in Mariposa County and do not receive a tax bill by November 10, 2021, contact the County Tax Collector's Office, at 4982 10th Street in Mariposa, CA or 209-966-2621, or PO Box 247, Mariposa, CA 95338. Failure to receive a tax bill does not relieve the taxpayer of the responsibility to make timely payments.

For TEXT and Email reminders go to mariposacounty.org, go to Treasurer/Tax Collector under Government then Departments and click on "Reminder Email" on the left.

The **FIRST INSTALLMENT** of 2021-2022 taxes is due and payable on November 1, 2021 and will become delinquent if not paid by 5:00 p.m. on December 10, 2021. Thereafter a 10% penalty will be added.

The **SECOND INSTALLMENT** of 2021-2022 taxes is due and payable on February 1, 2022 and will become delinquent if not paid by 5:00 p.m. on April 10, 2022. Thereafter a 10% penalty will be added and an additional cost of \$20.00.

BOTH INSTALLMENTS MAY BE PAID at the same time - but they **MUST** be paid when the first installment is due to avoid late fees.

SUPPLEMENTAL TAX BILLS are additional tax liabilities due to reassessment of your property value and are due on the date the bill is mailed to you. Please check the supplemental tax bill delinquent date in order to pay in a timely manner.

**A supplemental refund DOES NOT relieve you from paying the tax bill that you received

Payments may be made online at www.mariposacounty.org, or by mail sent to PO Box 247, Mariposa, CA 95338, and must be **POSTMARKED BY THE DELINQUENT DATE** to avoid late penalties. Payments may also be made in person at the County Tax Collector's Office, 4982 10th Street in Mariposa, CA between the hours of 8:00 a.m. to 12:00 p.m. and 1:00 p.m. to 5:00 p.m., Monday through Friday, holidays excepted.
